- Note 1 This report has been prepared on the cash basis of accounting.
- Note 2 Basic compensation for a Member of the Legislative Assembly (Member) is established under the *Members' Remuneration and Pensions Act*.
- Note 3 Members who hold parliamentary positions receive an additional salary that corresponds to a percentage of their basic compensation. If a Member concurrently holds two or more positions for which an additional salary is granted, the Member will receive only the higher amount.
- Note 4 Members that hold an executive position in government receive an additional salary that corresponds to a percentage of their basic compensation. Ministerial salaries are subject to a holdback of 20 percent, payable upon meeting the conditions as outlined in the *Balanced Budget and Ministerial Accountability Act*. Ministers' salary includes their ministerial allowance and payment of salary holdback from previous year.
